ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS RCS TRANSPORT INC.



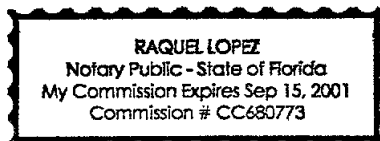
