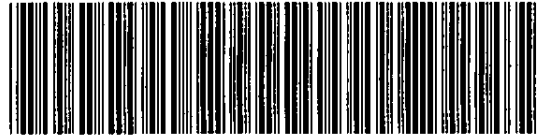

This is a request for the Department of Corporations to remove my name (Ronald M. Chazan) as an officer/director of the corporation (Summit Lending Corp.), a Florida corporation with the EIN 65-0858450.

Please let it be noted that on January 28, 2009 a Stock Purchase Agreement was signed whereby I sold 100% of the issued and outstanding shares of the corporation, Summit Lending Corp. to Hector E. Reyes.

The agreement called for the Purchaser to "complete and file with the Florida Department of Corporations the 2009 Annual Report changing the principal address of the corporation, deleting Seller as the registered agent, director and president of the Corporation and designating himself as registered agent, president and secretary of the Corporation."

At no time did I allow or give permission to the Purchaser to include me as an officer or director of the Corporation, nor was I aware until recently that I had been made an officer of the Corporation.

I presently have no association, nor do I wish to have any association with the Purchaser or the Corporation, and request that I be removed as an officer of this Corporation.
