The Name of the corporation shall be **WHITFIELD PROPERTIES OF TALLAHASSEE, INC.** The office shall be located at 1386 Tung Hill Drive, Tallahassee, Florida 32308.

II

The duration of the corporation shall be perpetual.

III

The corporation may engage in any activity or business permitted under the laws of the United States and under the laws of the State of Florida.

IV

The corporation shall consist of 100 authorized shares of stock with a par value of \$1.00.


