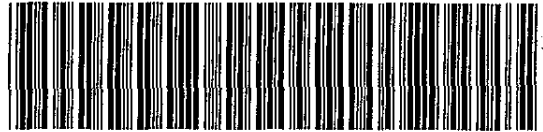

Dissolution of the corporation was approved and authorized on November 1st, 2004.


ARTICLE III. APPROVAL OF DISSOLUTION
