The undersigned incorporator, desiring to form a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Corporation is CIVCOM, INC.
The Principle address of the corporation is 13540 North Florida Ave., Ste.203

ARTICLE II

Duration

This Corporation shall have perpetual existence, commencing with the date of the execution and acknowledgement of these Articles of Incorporation, or if these Articles are filed more than five (5) days after such date, commencing with the filing of these Articles by the Department of State of the State of Florida.

ARTICLE III

Purposes

This Corporation is organized for the purpose of engaging in and transacting all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
