**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is **SEMINOLE EAST CORPORATION**

ARTICLE II. PRINCIPAL OFFICE

The principal place of business address and mailing address of this corporation shall be Suite 100, West Building, 1900 NW Corporate Boulevard, Boca Raton, FL 33431.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 (one dollar) per share.
