### ARTICLES OF INCORPORATION OF COUNTY LINE ROAD PHYSICIANS, INC.

I, the undersigned, make subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles Of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

#### **ARTICLE I - NAME**

The name of the corporation shall be COUNTY LINE ROAD PHYSICIANS, INC. and the corporate mailing address and principal place of business shall be 13028 County Line Road, Hudson, Florida 34667.


