# ARTICLES OF INCORPORATION

FOR

993, INC.

# ARTICLE I

The name of the corporation is: 993, INC. The mailing didress of the corporation is: 2200 So. Ocean Lane, Penthouse #3, Ft. Lauderdale, FL 33316.

#### ARTICLE II
