ARTICLES OF INCORPORATION

OF

A & M REAL ESTATE VENTURES, INC.

The undersigned subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE 1. - NAME

The name of this corporation is:

A & M REAL ESTATE VENTURES, INC.

ARTICLE 11. - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a) To engage in the buying, selling, leasing, operating, & manage real estate, to engage in all aspects of contracting of any & all construction trades for the erection of residential, commercial & industrial buildings & to engage in any & all other functions, services and/or activities considered as necessary, incidental, proper and/or ancillary, thereto, and to doall other things which may be desirable to achieve the purposes aforesaid and to operate a successful business.
- (b) To manufacture, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description.
