The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be Parking Associates, Inc. The principal place of business of this corporation shall be 4323 West Gulf Drive, Sanibel, FL 33957.

ARTICLE II. NATURE OF BUSINESS
