ARTICLE ONE - NAME

The name of the corporation is The Re/Collect Company.

ARTICLE TWO - DURATION

This corporation shall have perpetual existence.

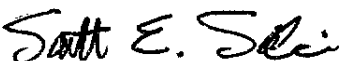
ARTICLE NINE - BY-LAWS
