1. The name by which this corporation shall be known, is: **RON'S WINDOW DECOR, INC.**

2. This corporation shall have perpetual existence.

3. This corporation is organized for the following purposes:

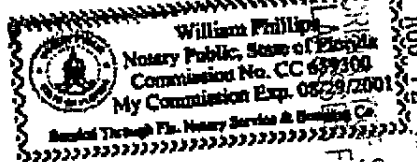
