

ARTICLE I  
CORPORATE NAME

The name of this corporation is BAY COURT ELECTRIC, INC.

ARTICLE II  
INITIAL PRINCIPAL PLACE OF BUSINESS

The corporation's initial principal place of business shall be 11156 Narragansett Bay Court, Wellington, Florida 33414.

ARTICLE III  
NATURE OF BUSINESS AND POWERS



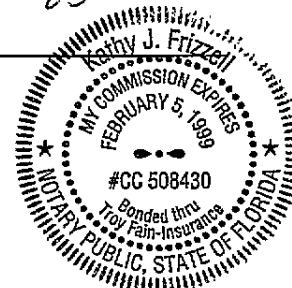
