I am hereby requesting that you reinstate this corporation and accept the enclosed Uniform Business Report for the year 2000 and forgive the penalties assessed against it for the reinstatement of the corporation. From my discussions with your office, I understand that this corporation was administratively dissolved in September, 1999, as a result of the failure to return the 1999 Uniform Business Report once it had been returned to Robert's Enterprises Of Bradenton, Inc., for the inclusion of the corporation's Federal Employer Identification Number. As I explained to a representative of your office, I did not receive the returned 1999 Uniform Business Report requesting such number. Further, in that the check made in payment of the 1999 Filing Fees was cashed, I had no reason to believe that there were any problems with the filing of 1999 Report; a copy of the 1999 Report being enclosed for your information. In fact, I was not aware of the dissolution until my attorney informed me of same upon his requesting a Corporate Detail Record from your office for his files.

Further, in that the corporation was dissolved in 1999, I did not receive the 2000 Corporation Annual Report. However, I am enclosing a completed and executed 2000 Report which my attorney obtained from your office as well as a check in the amount of \$150.00 as the filing fee for same.
