ARTICLE I - NAME

The name of this corporation is Florida Cleaning Resources, Inc., located at 5951 W. Flagler Street, #11, Miami, Florida 33144.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

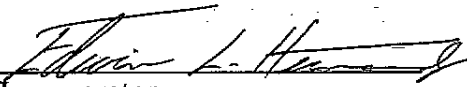

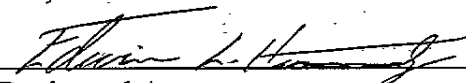

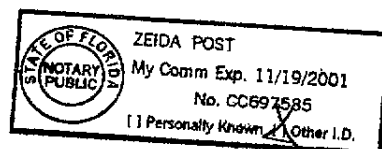
