**Bylaws**

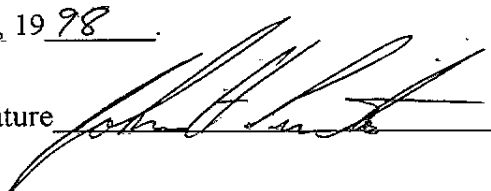

Corporate existence shall begin upon the filing of these Articles of Incorporation.

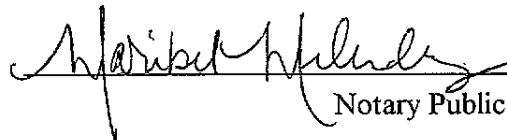

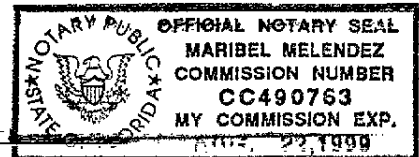

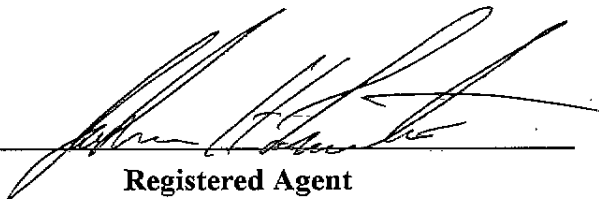
