The uncontested petition for disciplinary resignation, as provided by Rule 3-7.12, Rules Regulating The Florida Bar, with leave to seek readmission after five years, is granted subject to the continuing jurisdiction of this Court. See Florida Bar v. Ross, 732 So. 2d 1037, 1040-42 (Fla. 1998). Disciplinary resignation is tantamount to disbarment. Florida Bar v. Hale, 762 So. 2d 515 (Fla. 2000). As with disbarment, in seeking readmission to The Florida Bar, Respondent "may be admitted again only upon full compliance with the rules and regulations governing admission to the bar." R.
