ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the Corporation is Debra P. Brown, P.A.

ARTICLE II - DURATION

This corporation shall exist perpetually.



ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

The purpose for which this corporation shall be organized is to include every aspect of the business of rendering the same professional services to the public that Real Estate Licensees, duly licensed under the laws of the State of Florida, are authorized to render.
