

Dear Sir/Madam:

On June 28, 2001, I received from your offices the return of the Uniform Business Report for the above corporations stating that they had not been filed and that I owed an additional \$400.00 for a late fee on each corporation.

I mailed to your offices three Uniform Business Reports, the two above and 1031 Qualified Intermediary, LLC, with one check to cover all filing fees in the amount of \$350.00, check #1006 (\$150.00 for each corporation and \$50.00 for the limited liability company). The check was dated April 26, 2001 and was mailed with the three original Uniform Business Reports on Friday, April 27, 2001. Considering the United States Post Office delivery, these documents would have arrived at your offices no later than Tuesday, May 1, 2001 - which is the date they were due.

My first question is, why it has taken your offices over 42 days to process the Uniform Business Report? Secondly, why did you not properly credit the funds sent for the three entities? My Uniform Business Reports could have very well arrived in your offices on the date they were due, but you failed to process them on a timely basis, resulting in the fact that two of them they are now "late", why not the third?
