

**ARTICLES OF INCORPORATION
OF
HOWLAND INVESTORS, INC.**

The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be Howland Investors, Inc. The principle place of business of this corporation shall be 1250 Providence Boulevard Deltona, Florida 32725.

ARTICLE II. NATURE OF BUSINESS
