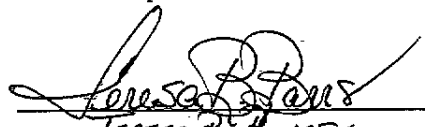
1. Frederick L. Bateman, Jr. is the President, and sole Shareholder and Director of Chatham Manufacturing Company, Inc. (the "Corporation").

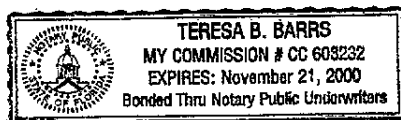
