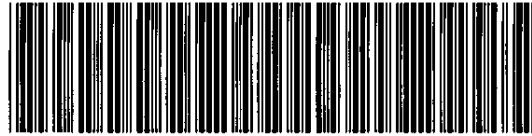



**ORDER DIRECTING THE RESPONDENT TO ACCEPT FILING**
