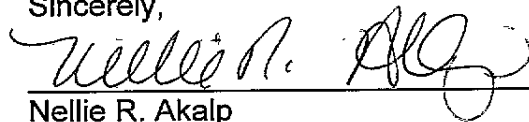

The aggregate number of shares which the Corporation has authority to issue is 1,500 shares of common stock with no par value.

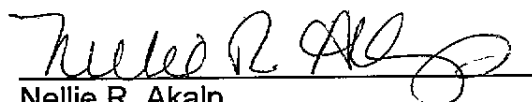
