ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Community Telco, Inc. The purpose of this corporation is to engage in any lawful business activity.

ARTICLE II

The existence of the corporation shall begin on August 1, 1998.

ARTICLE III

ARTICLE IV
