# ARTICLES OF INCORPORATION OF COMMUNITY TELCO, INC.

In compliance with the requirements of F.S. Chapter 607, the quadersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles incorporation for the purpose of organizing a business corporation.

## ARTICLE I
