To whom it may concern:

This letter is in response to a notice of corporate dissolution received by our office on July 31, 2000 of which a copy is enclosed.

Please be advised, our corporation inadvertently filed a timely 1999 Corporate Annual Report, however, it did not include a signature from the new registered agent. Although, the \$150.00 filing fee and report was filed by May 1, 1999, we subsequently learned in the year 2000 that our corporation was administratively dissolved.

We are requesting abatement of the \$600.00 reinstatement fee due to our not being notified by the Department of State that we were missing the signature prior to the corporation's dissolution.


We subsequently moved from the original location noted on the 1999 Corporate Annual Report and unfortunately did not receive a notice or indication that the report had a problem. Especially, since the \$150.00 filing fee check was paid by our bank in a timely manner.

It creates a hardship not being active and the additional fee is not afforded by the business. It is also excessive since we did pay our fee, filed the return timely and were not informed of any issues prior to dissolution.

We request a reinstatement of the corporation under the original status and enclosed is a payment in the amount of \$150.00, for the year 2000 Annual Report never received by our company due to the dissolution.
