The undersigned incorporator makes and files with the Department of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation is: IMPRESSIONS MORTGAGE, INC.

ARTICLE II

Principal Office / Mailing Address

The principal office and mailing address of the corporation shall be 2466 East Michigan Street, Orlando, Florida 32806 until such time as the corporation notifies the Department of state of the State of Florida of any change.

ARTICLE III

Term of Existence

This corporation shall commence as of the date of the filing of these Articles with the Secretary of State and shall have perpetual existence.

ARTICLE IV

Nature of Business

This corporation may engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE V

Capital Structure

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock, having a par value of \$1.00 per share.

ARTICLE VI

Initial Registered Agent and Registered Office

The initial registered Agent of this corporation shall be Ruby J. Schaffner, who is familiar with and accept the duties and responsibilities as Registered agent for said corporation. 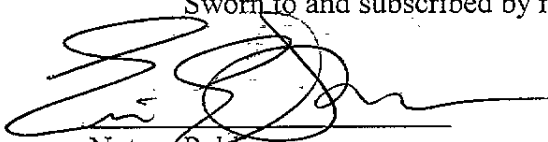
