

ARTICLES OF INCORPORATION Of IRENE BROWN MEDARY, P.A.



ARTICLE I CORPORATE NAME

The name of the Corporation is IRENE BROWN MEDARY, P.A. The principal address of the corporation is 710 Oak Commons Boulevard, Kissimmee, Florida 34741.

ARTICLE II

PURPOSE
