ARTICLES OF INCORPORATION

The undersigned, acting as incorporator, of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I. - NAME

The name of this corporation shall be N.J.C. ENTERPRISES INC.

ARTICLE II. - PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 2766 Heather Place Sarasota FL 34235.

ARTICLE III. - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV. - CAPITAL STOCK


ARTICLE VII.
