The undersigned incorporators, MARKWRIGHT and PAUL UMENSETTER, natural persons competent to contract, hereby present these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is FLOWERS ETCETERA OF PENSACOLA, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 8055 North Davis Highway, Pensacola, Florida 32514.

ARTICLE III - PURPOSE
