Dear Sir or Madam,

I am writing to you to request a waiver of the \$400.00 penalty for late filing of the enclosed Uniform Business Report (UBR). When I received this bill for \$550.00, I was shocked and did not remember that there was a charge of this magnitude from the state. Upon researching the issue, I discovered that the initial UBR was mailed in the spring and required a fee of \$150.00.

I never received the initial mailing, and with this my only second year of business, I was not looking for the mailing in the spring. We had three formal complaints with the Postmaster from Feb-May for nondelivery and misdelivery of mail (this can be substantiated if you need it).

I am a minority small business and trying to start my business with limited money using credit. If you choose not to give a one-time waiver of this large fee, I do not believe that I will be able to continue in business. PLEASE consider this request. The late payment is not because of any intent to deceive the state on my part. I now have it on my calendar to watch for the initial mailing in the Spring and contact you if I do not receive it by 15 April.
