This Corporation is authorized to issue 1,000 shares of One Hundred Dollar (\$100.00) par value.

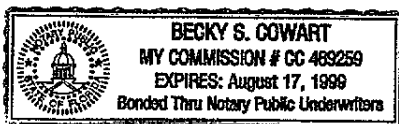


