ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE (Initial Principal OFFICE)

Article VI - Term of Existence

the period of duration of the corporation is perpetual.

Article VII - Nature of Business

1. This corporation is organized to transact any lawful business for which corporations may be incorporated under the laws of the State of Florida, and
2. To do such other things as are incidental to the foregoing, or necessary or desirable in order to accomplish the foregoing

Article VIII - Directors

the initial Board of Directors shall consist of two (2) members who need NOT be a resident of the state of Florida or Shareholder of the corporation

Article IX - Initial Directors

The Directors shall be elected in accordance with the By-Laws of the Corporation.

Articles of Incorporation of THE CornerSTONE Group, USA Inc.

Article X — Amendment of Articles of Incorporation

The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a stockholders meeting, with NOT LESS than a two-thirds (2/3) vote of the common stock.

Article XI — Preemptive Rights

The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, such shares of the stock of this corporation as may be issued for money, or any property or services from time to time, in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by a ratio of the authorized and issued shares of common stock held by the holder of all shares of common stock currently authorized and issued.

Article XII — Cumulative Voting

The shareholders of this corporation shall be allowed to vote their shares cumulatively so as to give one candidate as many votes as the numbers of directors to be elected, multiplied by the number of his/her shares, to distribute them among as many candidates as he/she may wish. Notice must be given by any shareholder to the President or a Vice President of said corporation NOT LESS than twenty-four (24) hours prior to the time for the holding of a share holder's meeting for the election of directors that said shareholder intends to cumulate his/her vote at said election.

Article XIII — Determination of Consideration

The stockholders shall have the right to determine in every instance the consideration for which the shares of the corporation shall be issued.
