The undersigned acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. - NAME

The name of the corporation is Gulfview Dipper Del, Inc.

ARTICLE II. - PRINCIPAL OFFICE

The street address of the principal office of this corporation is 9020 Gulf Shore Dr., Naples, Florida 34108.

ARTICLE III. - PURPOSE

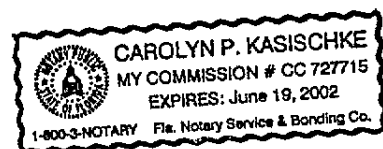
