ARTICLE I - Name

The name of this corporation is ORIGINAL SAVELLI'S FINE ITALIAN FOODS, INC., having its principal place of business at 2832 - 1st Avenue North, St. Petersburg, Florida 33713.

ARTICLE II - Purpose

- 1. This corporation is organized for the purpose of transacting any and/or all lawful business including, but not limited to, conducting the specific business of restaurant operation with sale of food and beverages, including alcoholic beverages, and all other related business matters.
