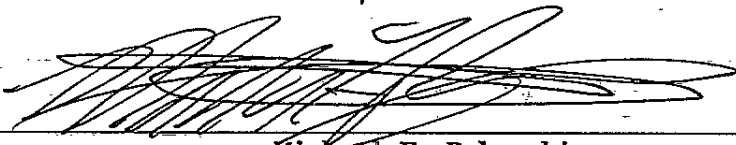

To the extent allowed by law, the shareholders and officers of the corporation assume no personal liability.

Article VIII Officers of the Corporation

Article IX Ownership Distribution and Transfer

In the event of death, ownership of the corporation shall be distributed as follows:

Michael F. Bukowski's death-his 51% will be transferred as follows: All to Jody Bukowski  
Jody Bukowski's death-her 49% will be transferred as follows: All to Michael F. Bukowski

In the event of the joint death of Michael F. Bukowski and Jody Bukowski, their total of 100% will be transferred to Mandie Bukowski, giving her a total of 100% ownership in the corporation

In the event of the joint death of Michael F. and Jody Bukowski, while their daughter, Mandie Bukowski, is still a minor, transfer of stock ownership will go to her Trustee, James R. Sands, Jr. until she turns 18 years old. Until that time, James R. Sands will operate the corporation in the same manner as prior to the joint deaths.

In the event of divorce and/or remarriage, no spouse shall be allowed to own a controlling interest in the corporation through agreement or community property, other than what is determined in these Articles of Incorporation

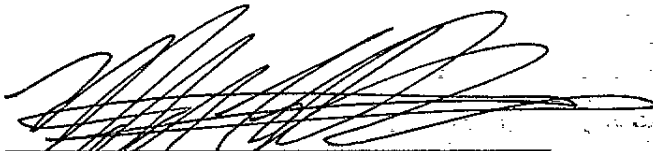

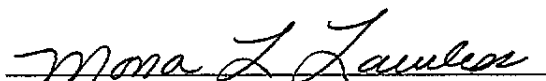
