

ARTICLES OF INCORPORATION

GAINESVILLE CHEERS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is GAINESVILLE CHEERS, INC.

ARTICLE II - DURATION AND COMMENCEMENT

This corporation shall have perpetual existence, commencing upon the approval by the Secretary of State.

ARTICLE III - PURPOSE

This corporation is formed for the initial purpose to open, manage, operate and franchise or license a restaurant or restaurants, but it may also engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a nominal or par value of \$1.00 per share.

ARTICLE V - ADDRESS

The street address of the initial registered office of the corporation shall be 5100 NW 53rd Avenue, Gainesville, Florida, 32608, and the name of the initial registered agent of the corporation at that address is NASRIN MOGHADAM, who hereby accepts the designation as Resident Agent.

Upon the death or incapacity of any shareholders, first choice of purchase on a pro rata share basis (as nearly as may be done without issuance of fractional shares) is reserved to the remaining shareholders. The pro rate share of those shareholders not wishing to purchase shall be offered on a pro rata basis to those remaining shareholders who do wish to purchase those shares.
