OF

The undersigned, being a natural person of legal age, does hereby desire to form a corporation under the laws of the state of Florida.

ARTICLE I

NAME

The name of the Corporation shall be **ATD CONSTRUCTION, INC.**, and the business address and location of the Corporation shall be **9309 9th Ave, Taft, Florida 32824.**

ARTICLE II

CORPORATE DURATION

This Corporation shall commence to exist upon the filing of these Articles of Incorporation. The duration of the Corporation is perpetual.

ARTICLE III

This Corporation reserves the right to amend, alter, change or repeal any provisions contained in this Certificate of Incorporation in the manner now or hereafter prescribed by statute.


