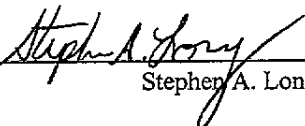

ARTICLE I NAME

The name of the corporation shall be S.A.L. AUTOMOTIVE, INC.

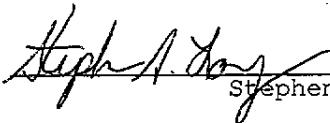
