**ARTICLES OF INCORPORATION**

**FOR**

**AMERI-LIFE AND HEALTH SERVICES OF CENTRAL GEORGIA, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I**

**Name**




