Articles of Incorporation of ARA Development Corp.



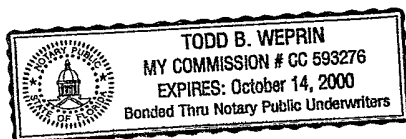


