ARTICLES OF INCORPORATION

Articles of Incorporation executed by the undersigned for the purpose of forming a corporation under the Florida Business Corporation Act.

ARTICLE I - NAME

The name of this Corporation shall be THE LENICK TEAM, INC.

ARTICLE II - DURATION AND PRINCIPAL OFFICE

This Corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law. The principal office is 11660 Night Heron Drive, Naples, Florida 34119, which shall be the corporation mailing address.

ARTICLE III - PURPOSE

The general purpose for which this corporation is initially organized shall be the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida, including but not limited to the operating of an educational video business. In carrying out the foregoing purposes, the Corporation shall have all of the common law and statutory powers and duties of a Corporation for profit under the laws of the State of Florida, except as limited or modified by these Articles or By-Laws.

ARTICLE IV - CAPITAL STOCK

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

ARTICLE V - REGISTERED AGENT

The initial registered office of this Corporation shall be at 11660 Night Heron Drive, Naples, Florida 34119, with the privilege of having its offices and branch offices at other places within or without the State of Florida. The initial registered agent at that address shall be Mary Lenick.

ARTICLE VI - DIRECTORS

This Corporation shall have at least one (1) Director, with the exact number to be fixed by the By-Laws. The Incorporator shall hold an organizational meeting to elect directors and complete the organization of the corporation or elect a Board of Directors who shall complete the organization of the corporation.
