ARTICLE X, AMENDMENTS



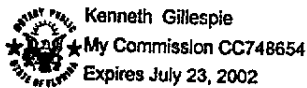
