The undersigned incorporator hereby executes, acknowledges and files with the of Florida Department of State the following Articles of Incorporation (the "Articles") for the purpose of organizing a corporation pursuant to Chapter 607, Florida Statute (the "Act").

ARTICLE 1 - Name

The name of the corporation is JTS CRAFTS INC.

EFFECTIVE DATE 8-12-98

ARTICLE II - Principal Office

The initial principal place of business or mailing address of the Corporation shall be 601 Brickell Key Drive, Suite 501, Miami, Florida 33131-2651.

ARTICLE III - Term of Existence

Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State, of the State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

Article IV - Nature of Business

The corporation is organized for the purpose of transacting any and all lawful business.

Article V - Authorized Shares

- (a) <u>Number</u>. The Corporation is authorized to issue Five Hundred (500) shares of common stock having a par value of \$1.00 each.
 - (b) Preemptive Rights. Shareholders shall have preemptive rights.

Article VI - Initial Registered Office and Agent

Article VII - Directors
