ARTICLE I-Name

The name of this corporation is MPC Building of Lake Placid, Inc.

ARTICLE II- Principal Office

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

ARTICLE XI-Amendment

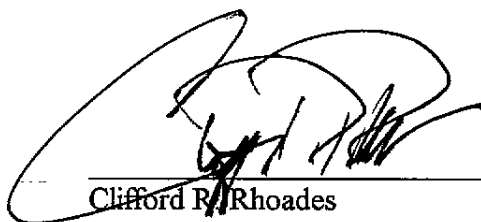

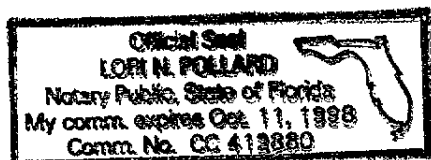
