The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation shall be **MY T-SHIRT, INC..**

**ARTICLE II
PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 8429 S.W. 46th Road, Gainesville, Florida 32608.

**ARTICLE III
PURPOSE**


**ARTICLE VII




