### ARTICLES OF INCORPORATION

ARTICLE 1 - NAME

The name of this corporation shall be :

P & M MORTGAGE SERVICES, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE
