ARTICLES OF INCORPORATION

The undersigned incorporator, Richard H. Tourtelot, an individual authorized to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME
