

ARTICLES OF INCORPORATION CRIDAN ASSOCIATES, INC.

98 Mile 17 PM 3: 18 The undersigned, acting as incorporator under and by virtue of the laws of the State of Florida, and particularly the Florida General Corporation Act, as provided in Chapter 607, Florida Statutes, and any acts supplementary thereto, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be: CRIDAN ASSOCIATES, INC. and its principal office and mailing address shall be:
