ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of the corporation is **VISION MI PUEBLO, INC.**, and principal place of business shall be located at 2105 Mosher Drive, Orlando, Florida 32810.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of common stock at Ten Dollars (\$10.00) par value, which shall be designated as "Common Shares."


ARTICLE XI - AMENDMENT


